

# 1. Child/Youth and Family Welfare

The organization has been providing direct services to children deprived of basic child rights in the community and their families through the Children, Youth and Family Welfare Branch by conducting various capacity-building activities including education, health treatment, and training workshops.

# a)Educational Assistance, School Enrollment, Health Services, Training and Capacity building for Children and Youth

The organization conducts various programs and initiatives to support children and youth in their education and overall development. These include school enrollment,



distribution of educational materials and uniforms, payment of school and tuition fees, provision of health insurance, health

education, treatment, and nutrition through programs such as the Dalit Girl Education and educational scholarship program. These services are provided regularly to children and



youth at both school and higher education levels.

Additionally, the organization divides supported children and youth into four groups and conducts visits throughout the year to enhance their abilities. Regular awareness-raising programs on child rights issues such as health awareness, cleanliness,

sexual violence abuse, drug addiction, child marriage, and goal setting are also organized.

Furthermore, the





organization engages forming and mobilizing children's groups, providing legal literacy, leadership development training, and extracurricular various and creative capacity



development activities such as writing, face-to-face debates, drawing, oratory contests, peace culture training, life skills training, career counseling, goal setting, and court dramas.

To create skill training and employment opportunities for youth, the organization supports technical education programs nursing, including staff radiography, beautician




training, tailoring, computer training, hotel management, and other training and technical education initiatives. In the current financial year, 99% of the 449 children and youths supported by the organization for school and higher education are regular attendees, with 100% of participants in the Secondary Education Examination (S.E.E.) passing successfully.





### b) Formation and Mobilization

Children's self-help groups have been established to promote children's rights and empower them. Children supported by the organization are encouraged to join these



groups, where they find inspiration, motivation, and opportunities for creativity and prosperity. The self-help groups are formed and mobilized regularly.

To enhance the capacity of these groups, various activities are facilitated, including meetings, leadership development, and the acquisition of useful life skills. Topics discussed include child marriage, drug addiction, internet safety, and other relevant issues. Additionally, training workshops are organized to provide further opportunities for capacity building.

In total, 142 members from 5 children's groups have participated in these activities and discussions, contributing to their personal growth and development.

### c) Health Services and Health Insurance

To ensure accessible and quality health services for the children supported by the organization and their families, agreements have been established with Fawa City Hospital and Life Care Diagnostic Center New Road. Patients recommended by the organization receive discounts on medical costs, including X-rays, tests, and medicines. Additionally, regular health services such as first aid, reproductive



health education, menstruation hygiene, and drug addiction counseling are provided. Transportation and facilitation to health centers or hospitals in



case of illness are also arranged.

In collaboration with local governments, the organization has facilitated health insurance for 985 individuals from 197 families. This initiative aims to make state-provided health services more accessible to families in need.

#### b) Peace, Culture, Alternatives to Violence Training Workshop

Similar to previous years, a training workshop on the culture of peace and alternatives to violence has been conducted for children, parents, teachers, and staff. This year, a total of seven training sessions were


completed: two for children, two for parents, and three for school teachers. A total of 173 individuals participated in these sessions, gaining valuable skills and insights into peaceful conflict resolution.

# e) Family support and income generation:

To enhance the capacity of families facing challenging circumstances, the organization has provided various capacity-building activities to the families of children under its support. This year, a total of 386 families have benefited from the services offered by the organization.



Out of the 386 families supported by the organization, 271 families have taken the initiative to collect and mobilize their savings, engaging in household chores and establishing small businesses to

generate income. Additionally, 260 of these families actively participate in the Suryamukhi Agricultural Cooperative.

To further empower these families, a wide range of





programs has been conducted, including household accounting, cooperative management, peace culture alternatives training, violence workshops, to awareness sessions on gender violence, family planning, menstrual hygiene, distribution of sanitary pads, sexual violence drug addiction prevention. awareness, personal hygiene education, literacy, legal financial literacy, educational





observation tours, health education, health insurance facilitation, medical treatment, distribution of nutritious food, organic farming, and business planning training. These programs aim to equip families with essential skills and knowledge to improve their socio-economic status.

Out of the 386 families facing financial hardships, 271 families have successfully elevated their economic status by engaging in various small businesses such as retail shops, tailoring, vegetable and fruit vending, driving, and beekeeping.

# f) Capacity Development of Schools and School Teachers:

A training workshop on culture of peace and alternatives to violence has been completed for 52 teachers of 3 schools to develop qualitative education and child-friendly learning



practices in schools supported by CHILDREN-Nepal. To get information about the educational status of the children enrolled in the school



and to provide necessary support, programs such as meetings and interactions with the school and school teachers have been regularly organized. In 3 schools where children study supported by the organization, printers,



swings, and children's lunches have been supported to support teaching and learning and extracurricular activities.

#### 2. Learning Resource Center

The Learning Resource Center, established by the organization, aims to provide educational support to children attending government schools and within the community. Through computer education and access to a library, the center endeavors to equip children with modern technology and knowledge. This fiscal year, a total of 121 children (80 girls) have benefitted from the services offered by the Learning Resource Center.

### a) Computer Delivery/Training

Children are instructed on various aspects of computing, including understanding the computer, its characteristics, working cycle, and hardware/software components. Practical



sessions involve activities such as Tux Math, painting, and typing, enabling children to perform mathematical calculations and create documents using software like LibreOffice. Additionally, essential life skills such as loan calculation, bill management, and PowerPoint presentations are taught.

### b) Interactive Board

Utilizing the Interactive Board, children are engaged in interactive learning experiences. Mathematics, children's stories, and poems are taught using videos and documentaries. This approach fosters independent learning skills, encouraging children to explore and study topics of interest online. Furthermore, children are tasked with project work and presentations using the Interactive Board.

#### c) Library

In addition to computer classes, children are encouraged to develop good handwriting skills and cultivate a habit of reading and writing. The library serves as a resource for children to access a variety of



books covering genres such as stories, poetry, drama, and general knowledge. Throughout the year, children have read 537 books across different subjects, improving their reading comprehension and writing abilities.



#### d) Extracurricular Activities

Various recreational activities, including music, dance, painting, and sports, are organized to uncover and nurture the talents of children. Competitions in painting, poetry recitation, handwriting, and typing are held, with certificates awarded to participants. Additionally, children undergo assessments on life skills and knowledge acquired, with certificates distributed to those who pass.

#### 3. Fulbari Resource Center

# a) Running of Street and Orphan Children Protection and Management Center

The organization has continued its efforts to rescue, protect. and rehabilitate children from the streets of Pokhara through its Street and Orphan Children Protection and Management Center at Fulbari Resource Center. Despite the challenges by the COVID-19 posed pandemic, all 54 rescued children have been successfully rehabilitated either with their families or placed in various organizations





institutions. Additionally, the center has provided accommodation, food, healthcare, education, and counseling services to six homeless



children during this fiscal year. Efforts to reunite children with their families have been fruitful, with five children successfully reintegrated into their families in **Rohwar** with the assistance of local authorities. Regular coordination with governmental bodies such as the Ministry of Education, Science, Technology, and Social Development Office, Gandaki Province, Pokhara Metropolitan City, and Annapurna Village Police has ensured effective operation and rehabilitation outcomes for all children under the center's care.

#### b) Organic Farming, Vegetable Cultivation, and Animal Husbandry

The Fulbari Resource Center has focused on sustainable agriculture practices, including the construction of two tunnels vear-round vegetable cultivation and the planting of various fruits and vegetables. Organic farming techniques have been employed, along with the initiation of livestockrearing projects involving chickens and goats. The center has achieved self-sufficiency in vegetable production and generated additional income



by selling surplus produce and livestock products.

# c) Training Workshops

the Throughout the year, conducted center has 11 training workshops targeting staff, farmers, parents, and workshops children. These topics cover various such ecological agriculture



promotion, botanical gardens, eco-tourism, yoga meditation, and human resource development. Additionally, efforts have been made to engage with organizations, businesses, educational institutions,



cooperatives, banks, and financial institutions in Pokhara to promote and raise awareness about the center's initiatives.

#### d) Infrastructure Development and Maintenance

Maintenance activities have been undertaken to upkeep the buildings, accommodation facilities, training hall, furniture, machinery, water, and electricity at the Fulbari Resource Center. Landscaping



efforts around the center have enhanced the aesthetics and usability of the premises. Infrastructure development projects, including the construction of a concrete entrance gate, have been initiated and completed during this period, further enhancing the functionality and appeal of the resource center.

#### 4. Social Mobilization and Project Development

CHILDREN-Nepal actively participates in sustainable livelihood development activities aimed at achieving the Sustainable Development Goals set by the international community until 2030. This year, our focus remained on



Lewade and Fallapani in Kaski district, as well as the Gunjara community in Tanahun district. The objective is to increase the involvement of women from the poorest, Dalit, and marginalized families in activities promoting sustainable living standards and empower them.

Through our project initiatives, a total of 164 families in Annapurna Rural Municipality-1, Kaski district (including 40 families in Lewade and 63 families in Fallapani), and 61 families in Myagde Rural Municipality-2, Tanahun district (in the Gunjara community) have received services and support.

#### a) Capacity Development of Organization Employees

During this period, training workshops were conducted focusing on women's rights, gender equality, inclusion, and the social working style of the organization's employees. workshops aimed These opportunities provide to



for capacity development. A total of 20 employees and board representatives participated in these training sessions.

# b) Promotion of Cooperation

A total of 155 farmers from Fallapani, Lewade, and Gunjara communities have joined three cooperatives, aiming to enhance the living standards of women and marginalized groups in the local community. Assistance has been provided



to cooperative members in cooperative management, accounting, savings mobilization, and other relevant areas. Training sessions on peace culture, non-violent options, gender equality, women's rights, human rights, inclusion, communication skills, courtroom drama, and constructive dialogue in the community were organized to foster mutual cooperation among cooperative members. The cooperatives have successfully mobilized capital, with Lewade community cooperative collecting Rs. 2,50,000, Fallapani cooperative collecting



Rs. 8,64,000, and Gunjara community cooperative collecting Rs. 8,22,000.

#### c) Capacity Building of Farmers

The organization has been supporting farmers in organic farming, environment-friendly technology, market promotion, and business planning. Training sessions on organic farming technology, participatory quality control



(PGS) method, food processing, grading, packaging, and business planning were organized. Additionally, opportunities for visits and experience sharing were provided. Separate PGS management committees have been formed in all three communities, and farmers are actively engaged in the production of organic agricultural produce through cooperatives.

# d) Promotion of Organic Agriculture in the Community

Awareness activities promoting organic agriculture were organized in cooperation with rural cooperatives in Fallapani, Lewade, and Gujara communities. Additionally, teej song competitions on organic farming and environmental protection were conducted at the municipal level. Market groups formed in these communities organized organic food fairs at the respective municipality level, resulting in increased

production and consumption of organic agricultural produce in the community.

# 5. Skills Development and Employment Branch, Suryamukhi Handicraft

Continuing the practice of applying the 10 principles of fair trade, the organization has maintained its commitment to providing vocational training and





employment opportunities to women facing challenges through the Suryamukhi Handicraft program. This year, efforts were focused on empowering women socially and economically while promoting fair trade practices. Training sessions in tailoring, cutting, and handicraft production were conducted to create avenues for employment and to market products made by women producers.

### a) Skills Development Training and Production

Under the Suryamukhi Handicraft program, a total of 14,472 items were produced this year, including 178 varieties such as cotton masks, school uniforms, pants, frocks, sanitary pads, bags, food items, and t-shirts. Fourteen women participating in the program received vocational training, leading to employment opportunities. The products crafted by these women are of exceptional quality and have gained popularity in local, national, and international markets.

# b) Education, Health, Safety, and Capacity Development

Regular services such as first aid, health insurance, accident insurance, and emergency support are provided to the producers engaged in Suryamukhi handicrafts. Additionally, educational support for the children of these producers is ensured. Safety measures such as wearing masks, slippers, aprons, and regular hand washing with soapy water or sanitizer while working in the production room are strictly adhered to. Furthermore, financial literacy sessions, as well as training related to savings collection, mobilization, agriculture, organic farming, and environmental sustainability, are conducted



for the producers. Special events such as the Haritalika Teej celebration, including dancing, singing, and recreational activities, as well as an annual picnic and a three-day study tour from Pokhara to Muktinath, are organized for the producers and their families.

#### c) Design

Innovations in design are prioritized, with 24 new designs introduced this year, including aprons,

lockets, child bibs, oven gloves, and hand puppets. Additionally, 14 existing designs were modified based on customer feedback and preferences.

#### d) Fair Trade and Market **Promotion**

The organization continues commitment its to trade practices and market promotion through collaborations with various stakeholders. Renewed memberships with FTG-WFTO/WFTO-Asia. Nepal. and adherence to the 10 principles of fair trade remain integral. World Fair Trade Day is celebrated with various programs, and participation local. national. international fair trade fairs is consistent. Handicraft items are showcased in various fairs, including virtual expos, and promotional videos are produced to expand market reach. Collaborations with international organizations,










associations, local online platforms ensure the widespread availability handicraft products. Promotion efforts are amplified through social media campaigns, including hashtags, photos, and videos on significant occasions. Participation in international events and summits further strengthens the organization's advocacy for fair trade and promotes Nepali handicrafts on a global scale.

# 6.Institutional Development, Secretariat, Finance, and Administration

In alignment with the organization's vision, goals, and objectives, activities planned annually by various branches are consistently executed in adherence to the organization's statutes, regulations, policies, and code of conduct. Additionally, programs are monitored and supervised.

#### **Board Meetings**

The working committee convenes board meetings to review organizational activities, prepare annual programs and budgets, and discuss policy matters. During this period,



five board meetings were conducted.

#### **Staff Meetings**

Monthly staff meetings are held to review and plan organizational activities, share information, and discuss pertinent issues among employees. Sixteen monthly meetings were held during this



period, with decisions implemented accordingly.

#### Institution Renewal

The organization complies with statutory requirements by paying taxes, obtaining tax payment certificates, and submitting progress and financial reports to relevant authorities. Renovation work for the institution was completed by the end of Asar, 2079/080.

### **Annual General Meeting (AGM)**

The organization's 26th AGM was conducted with various programs, including presentations of the annual progress and financial reports for 2078/079. The program





and budget for F.Y. 2079/080 were also approved during the meeting.

#### **Annual and Half-Yearly Review**

Organizational activities are regularly reviewed, and reports and plans are prepared accordingly. Partnerships with various national and international organizations, such as the German Nepal Aid Association and DIB Denmark, have been established for specific projects.

### Partnership, coordination and cooperation:

Development of cooperation and partnership, during this period, the German Nepal Help Association for the education and empowerment program of Dalit girls, the DiB Denmark for the project to increase the participation of women and marginalized groups in sustainable living standards development activities, and the Social Development Office of the Government of Nepal for the operation of the Street





and Homeless Children Protection and Management Center. has been partnered with Kaski. Likewise, Manisa UK has been coordinated and collaborated with Manisa UK for computer training-Sakai resource center, Bring Back Smile to Nepal, Love That Stuff, Rotary Club of Humbeg Hanse for menstrual training and distribution of sanitary pads. While developing partnership, coordination and cooperation with local bodies, the District Coordination Committee Kaski and Tanahun, Pokhara Metropolitan Municipality, Kusma Municipality, Myagde Rural Municipality and Annapurna Rural Municipality including various related agencies and networks including DPAC, MPAC/LPAC, program, progress and plan presentation is done regularly.

#### Collaboration/Partnership with Banks

Partnerships with local banks, including Laxmi Bank, Kamana Bank, Lumbini Development Bank, and NMB., have facilitated the



distribution of sanitary pads to girls and women in need through Corporate Social Responsibility (CSR) funds.

#### **Program Progress Report and Plan**

Regular progress reports for programs and projects are prepared and submitted to partner organizations and concerned bodies on a monthly, quarterly, half-yearly, and annual basis. Self-assessment

reports submitted to the World Fair Trade Organization (WFTO) have also been completed.

#### **Honors and Awards**

The organization has received recognition for its campaigns and contributions. Due to its activities, Gandaki province has been awarded the Best Province as participation children's in Nepal. Additionally, letters of appreciation have been





received for contributions to children's education.

# Publication, Broadcasting, and Distribution

Various materials, including leaflets, catalogs, calendars, annual reports, and fair trade posters, related to organizational programs and activities have been published, broadcasted, and distributed. News of organizational activities has been disseminated through various media platforms, including newspapers, social media, and the organization's website.

# Program Monitoring, Supervision, and Evaluation

The organization diligently monitors and supervises its programs,

overseen by the senior program officer, executive director, and working committee members. Regular monitoring occurs in collaboration with partners such as the German Nepal Cooperation Association, DIB Denmark, Manisa UK, and





government bodies like the Social Development Office and local municipalities. Evaluation groups, appointed by the Social Welfare Council, assess program effectiveness. The organization also undergoes monitoring audits by the World Fair Trade Organization (WFTO) to maintain its Guaranteed Fair Trade membership.

#### **Institutional Policies, Rules, and Guidelines**

### Main achievements of the F.Y. 2079/080

- The organization successfully provided services to 1,662 primary target groups, 3,759 secondary target groups, and indirectly impacted 23,280 people.
- This year, the organization provided educational scholarships and various services to 459 children (67 of whom are from marginalized backgrounds). Among them, 99% of the children attended school regularly, and 100% of those who participated in the exams passed.
- In collaboration with the German Nepal Aid Association, assisted 260 Dalit girls and their families to improve their living standards. Starting from 2080/081, the project aimed to support 300 people, including 40 studying vocational skills, technical and higher education.
- A total of 121 children and youths, including 41 children, received basic computer education, library access, and practical skills development, enhancing their technical knowledge and abilities.
- Through the education and empowerment program for Dalit girls, health insurance was provided to 985 family members from 197 families, facilitating access to health services through insurance cards.
- The organization's education program for Dalit girls was evaluated positively by the Social Welfare Council and the German Nepal Aid Association.
- 550 families directly engaged with the organization participated in empowerment trainings and workshops, with 426 families joining cooperatives, and actively involved in savings and business activities.
- Farmers from Lewade, Fallapani, and Gunjara communities obtained quality certification for their organic agricultural produce, enhancing their access to urban markets.
- Municipal organic food fairs were organized in collaboration



with rural municipalities, promoting organic agriculture and ecofriendly technology.

- Farmers from Lewade, Fallapani, and Gunjara communities saw an increase in their average annual income from Rs. 30,930 to Rs. 65,931.
- Four agricultural cooperatives formed in Lewade, Fallapani, Gunjara, and Masbar successfully collected shares totaling Rs. 42,85,790, contributing to institutional development.
- The organization contributed to a decrease in violence against women in Lewade, Fallapani, and Gunjara communities from 54% to 5%.
- Fulbari Resource Center conducted 11 training workshops and promoted its activities through leaflets and social media.
- Ecological agriculture and living were promoted at Phulwari Resource Center, with organic farming and poultry raising initiatives.
- Employees participated in over 39 training workshops, enhancing their service delivery skills.
- The organization contacted various partner organizations and agencies to explore resource possibilities for project development.
- Risk analysis tools, emergency response plans, and disaster risk management policies were developed during this period.
- The impact assessment of the ERL project received positive feedback from the Social Welfare Council.
- A total of 20 full-time employees and 23 personnel, including interns, served the organization regularly.
- Suryamukhi Handicrafts provided employment to 14 productive women, producing 14,472 items of various types.
- Women in Suryamukhi Handicraft improved their economic and social standards through skills training and access to healthcare



services.

- The organization celebrated World Fair Trade Day and Women's Day and promoted fair trade through participation in various events.
- Sales and grant assistance worth Rs. 42,81,726.50 and Rs. 9,89,891.90, respectively, were received for the Suryamukhi Handicraft Program.
- Fewacity Hospital Pvt. Ltd. and Life Care and Research Center New Road, Pokhara offered discounts to members and employees of the organization.
- The organization collaborated with various national and international organizations, seeking resources for new projects.
- Internal resources, including sales and bank interest, helped raise Rs. 1,18,89,941.57 for the organization.
- The organization aimed to increase the percentage of income sourced internally from 27% to 40% this year.

#### **Problems and challenges faced**

- Due to the impact of the COVID-19 pandemic and the global economic crisis, there are challenges in raising necessary resources as sponsors are gradually reducing or discontinuing their support.
- Furthermore, there is a lack of awareness among children and parents about safe internet usage, leading to an increase in incidents of online violence and abuse.
- The organization faces difficulty in developing new design items tailored to meet the demands of both local and international markets, resulting in a reliance on existing designs.
- The demand for goods from national and international markets is decreasing due to the effects of COVID-19 and the economic crisis, making it challenging to procure raw materials promptly.



- There are prevalent tendencies towards seeking allowances and monetary benefits in communities and target groups.
- Social disparities persist within communities, compounded by women bearing the dual burden of household and agricultural responsibilities, alongside a general community apathy towards agriculture and a youth preference for foreign opportunities.
- Efforts to maximize the utilization of resources available at the organization's Fulbari Resource Center are still underdeveloped.

# Major Programs and Activities Planned for the Next Fiscal Year 2080/081

#### **Empowerment of Children, Youth, and Family Services**

- Provision of educational support, including assistance with school admissions, payment of fees, distribution of school uniforms, and provision of school supplies for children from Dalit and underprivileged communities, along with offering education and extra classes.
- Facilitating healthcare services for children and their families, including reproductive health and menstruation awareness programs, first aid training, health insurance coverage, emergency health assistance, and distribution of sanitary pads.
- Organizing creative activities such as court dramas, painting sessions, handwriting practice, recitations, storytelling, and engaging in various interactive exercises to foster creativity.
- Educating children on their rights, duties, responsibilities, goal setting, leadership development, career counseling workshops, and imparting useful life skills.
- Conducting training workshops on alternatives to violence and peace-building measures for children, youth, and their families to cultivate a culture of peace.
- Assisting in providing technical education and vocational training



for children and youth to enhance their skills and employability.

- Organizing educational tours for children and youth to broaden their knowledge and exposure to various learning experiences.
- Conducting empowerment training workshops for families and youth, covering topics such as household accounting, financial and legal literacy, gender equality, combating violence against women, along with providing psychosocial health and counseling services for children and families.
- Facilitating monthly family meetings, conducting orientation sessions, and providing education related to income generating, including clarifying family responsibilities, roles, and duties towards children.
- Encouraging families to join the Suryamukhi Agricultural Cooperative, supporting them in savings collection, incomegenerating activities, and ensuring adherence to cooperative policies and rules.
- Providing training for school teachers on promoting a culture of peace and alternatives to violence, in addition to distributing essential school supplies necessary for teaching and learning.
- Conducting capacity-building training workshops for staff, participating in training workshops, and organizing educational observation tours.
- Offering various empowerment and capacity development services, including computer education, to children through learning centers.
- Providing orientation training and education related to waste management and proper garbage disposal practices for families.



#### **Learning Resource Center**

#### **Computer Lab Operation**

- The objective of the computer lab is to provide basic computer skills to children. This includes practicing the preparation of mathematical and other documents using an interactive board to teach children according to the class content.
- Additionally, the lab will offer courses on TuxMath, Paint, and Typing, as well as LibreOffice Base. Students will also learn to create PowerPoint presentations and develop presentation skills.

#### **Inclusive Art Practice (Interactive Activity)**

 The aim is to enhance children's abilities through training in various arts and activities. This includes sessions on singing, music, painting, dance, and sports. The program will also offer life skills training and practical education to further develop the children's talents and abilities.

#### **Running a Library**

 The library's goal is to encourage children to read books on various subjects and in different languages. It will create opportunities for reading and familiarize children with research practices. The library will also conduct various extracurricular activities and capacity development training sessions for children to enhance their learning experience.

#### **Fulbari Resource Center**

#### a)Promotion of Environmental Agriculture

 Cultivating various types of vegetables using organic techniques around the Fulbari Resource Center and planting fruit seeds to produce and practice environment-friendly



methods.

- At the Fulbari Resource Center, planting winter and spring vegetables according to the season in plastic tunnels. Practicing techniques such as compost manure, ground nurseries, sky nurseries, vermicomposting, Jiwatu, Jivamrit and Bodo paste
- Planting and preserving a variety of fruits including bananas, pears, peaches, walnuts, kiwis, mangoes, and cardamom.
   Additionally, cultivating different types of pulses and Asian broom grass (amriso/Thysanolaena maxima).
- Protecting and expanding the cultivation of Sil Timmur (Zanthoxylum armatum) trees, as well as packaging and selling the produced Sil Timmur.
- Regularizing goat and poultry rearing, while also practicing models for buffalo, rabbit, and bee rearing.
- Maintaining regular cleaning around the center by uprooting unnecessary grasses and weeds in the premises of the Suryamukhi Resource Center, and protecting useful plants.

#### b)Conducting Training and Promoting the Center

- Conduct various internal training sessions for children, youth, farmers, parents, teachers, employees, and social workers to develop their capacities. This includes organizing workshops and training programs.
- Promote the center by preparing promotional materials such as leaflets and videos for the Fulbari Resource Center.
- Enhance the center's visibility by meeting and discussing with various organizations and business establishments to facilitate the environment for conducting various types of external training workshops.
- Develop programs and plans to transform the Fulbari Resource Center into an Eco-Centre.



#### c) Protection and Maintenance of Resource Centers

- Arrange for the purchase of the remaining land in the middle of the center and set up a compound fence.
- Maintain and paint the training hall, kitchen, biogas facility, accommodation areas, solar panels, electrical systems, water taps, bed extensions, and other physical materials and structures.
- Develop the uppermost hall of the center to be used as a room for yoga meditation and a multi-purpose hall.
- Ensure easy walking access from the main entrance of the center to the training facility.

#### **Community Mobilization and project development**

## a)Extension Program for Promoting Good Nutrition among Children and Youth

- Present the project to partner schools, village councils, and social welfare councils for approval.
- Compile baseline and final project data. Form court theater groups in schools and provide training and education.
- Offer training on organic farming, nutrition, environmental protection, climate mitigation and its effects, and gender discrimination. Perform court dramas on these topics.
- Assist in conducting community awareness programs for children and teachers.
- Implement organic farming, eco-friendly techniques, and gardening in schools for teacher facilitators.
- Conduct capacity development training on management and facilitation skills and methods.



- Help schools practice gardening, raised bed farming, vertical farming, terrace farming, and natural farming, and establish environment-friendly technologies.
- Provide training on school garden construction and organic farming techniques to children.
- Create opportunities for school teachers and children to share knowledge and experiences with other organizations/ cooperatives practicing organic farming, gardening, and ecofriendly techniques.
- Offer training to parents on kitchen gardening and organic farming. Facilitate the presentation of new learning experiences by children to parents and provide seeds and plants for starting kitchen gardens.
- Conduct tree planting campaigns for children and support parent education programs on the benefits of useful plant species.
- Demonstrate kitchen gardening in the community and support parents in constructing kitchen gardens.
- Assist in conducting awareness campaigns such as meetings, interactions, and processions for children and teachers, supporting the children's involvement.
- Advocate at the local municipality and state level for the implementation of practical learning and curriculum in schools on environmentally sustainable agriculture and climate change.
- Organize study tours for employees of organic farming schools, eco-friendly technology schools, and good practice stations related to gardening and community gardening.
- Regularly visit the project area for facilitation, monitoring, supervision, and evaluation of the project.



# Suryamukhi Handicrafts in Skill Development and Employment

- Technical Training for Women: Provide training to women to produce various materials such as T-shirts, sanitary pads, masks, food, caps, etc. Offer sewing training for school uniforms and assist women in preparing uniforms and producing goods for the local market.
- Sanitary Pad Production: Teach women to make sanitary pads and distribute and sell these pads to underprivileged women and girls.
- Inventory Management: Record the purchase of raw materials and daily production, check the quality of each product, and manage the store efficiently.
- **Social Activities:** Organize a fun picnic, including dancing and eating programs, for the producers on the occasion of *Teej*.
- **Support for Workers' Families:** Distribute educational materials and school uniforms to the children of women working in Suryamukhi Handicrafts. Provide first aid, health awareness, and regulate health and accident insurance arrangements for producers.
- Capacity Development: Offer training on various subjects such as gender, organic crops, kitchen gardening, and environmental protection to improve the economic and social living standards of women in difficult situations. Provide vocational training and employment opportunities.
- Product Design and Marketing: Design and revise products according to customer preferences, and manufacture and promote these products. Expand access to local, national, and international markets for Sunflower Handicrafts.
- Customer Relations and Sales: Maintain regular contact with existing customers, seek new customers, take orders, and make sales. Follow up with shops/outlets selling handicrafts across the country, take orders, and promote fair trade.



- Fair Trade Membership and Reporting: Renew membership with Fair Trade Group Nepal, WFTO Asia/WFTO, and prepare and send required information and reports to WFTO/FTG on time. Participate in Fair Trade Group Nepal meetings, general meetings, and virtual webinars/WFTO Asia Summits.
- Trade Fair Participation: Promote various handicrafts and fair trade by participating in national and international trade fairs. Sell and promote handicraft items through online platforms like Daraz and Smart Doko. Participate in Virtual B2B Fair Trade Fairs organized by WFTO Asia. Update promotional materials such as Fair Trade posters, catalogues, leaflets, websites, and small promotional videos.
- Event Participation: Participate in events such as WFTO Day, International Women's Day, and meetings with stakeholders including WFTO and Fair Trade Group Nepal to promote fair trade.
- Small Projects Development: Develop small projects related to fair trade to provide social services and employment opportunities for producers.

#### Institutional Development, Economic, and Administration

- **Strategic Planning:** Review the organization's strategic plan and hold a workshop to prepare the strategic plan for the next three years.
- Policy and Statute Revisions: Revise and amend the organization's statutes, administrative management rules, and financial management rules as needed, and regularly implement existing policy rules. Meet and discuss with stakeholders to revise and amend scholarship guidelines as necessary.
- Advocacy and Coordination: Advocate with stakeholders regarding target groups, and regulate coordination, cooperation, and solidarity with other organizations and bodies.



- Policy Updates: Review and update policies such as Child Protection Policy, Environmental Protection and Disaster Management Policy, Good Governance and Transparency Policy, Inclusive and Equal Opportunity Policy, and Risk and Disaster Management Policy to ensure they meet current needs and implement them accordingly.
- Capacity Building: Conduct various training workshops to enhance the capacity of staff, board members, and other members of the organization. Participate in training workshops organized by other entities. Provide opportunities for staff to participate in forest dinners and study tours.
- Annual General Meeting and Financial Management:
   Organize the 27th Annual General Meeting, audit annual
   accounts, prepare the annual budget, and ensure timely
   renewal of the organization and its memberships with various
   organizations and networks. Coordinate and collaborate with
   national organizations and government agencies to promote

   and fair trade through the organization's contact office in
   Kathmandu.
- Program Coordination: Conduct programs in coordination and collaboration with various national and international organizations, local levels, and provincial and federal government agencies. Regulate monitoring and supervision procedures to ensure the effectiveness of activities and projects. Regularly conduct ongoing activities and projects while developing new ones and seeking partner organizations and resources.
- Resource Mobilization: Develop coordination and cooperation
  with various banks and raise resources by partnering in their
  CSR programs. Prepare and submit financial and progress
  reports for each program and project to partner organizations
  on time.



- Board and Staff Meetings: Conduct regular board meetings to review activities, make policy decisions, and implement them. Hold monthly staff meetings to review completed activities and prepare and implement monthly plans based on the annual plan.
- Administrative Updates: Maintain updated records of administrative functions, including recruitment, appointments, attendance, leave, letters, and employee information. Contact landowners around the flower resource center and take necessary steps to purchase any remaining land. Study the feasibility of operating the Fulbari Resource Center more systematically and efficiently.
- Monitoring and Evaluation: Arrange necessary monitoring and evaluation of projects run by the organization, in coordination with the Social Welfare Council. Present new projects to district/municipality and rural municipality project advisory committee meetings for approval and coordinate and cooperate as needed.
